

**ORDINANCE NO. 2022-5**

**AN ORDINANCE CANCELLING THE MAY 7, 2022 CITY OF CANTON GENERAL ELECTION; DECLARING BLAKE FOWLER, JIM FULLER AND CHASE MELTON ELECTED AS CANTON CITY COUNCIL MEMBERS FOR A TWO-YEAR TERM; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, the Canton City Council adopted Ordinance No. 2022-1 on January 18, 2022, ordering the May 7, 2022, City of Canton General Election to elect three council members; and

**WHEREAS**, the city secretary has certified in writing there is no proposition on the ballot, that no person has made a declaration for write-in candidacy, and that each candidate on the ballot is unopposed for election to office; and

**WHEREAS**, The Election Code under these circumstances, authorizes the city council to cancel the election and declare the candidates elected to office;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CANTON, TEXAS:**

Section 1. The City of Canton hereby cancels the election scheduled to be held on May 7, 2022, in accordance with Section 2.053(a) of the Texas Election Code.

Section 2. The following candidates have been certified as unopposed and are hereby elected as follows:

Section 3. The attached Order of Cancellation shall be posted on Election Day at each polling place that would have been used in the election.

Section 4. This ordinance shall take effect immediately upon its passage.


